- 1. The subheading "Restrictions on purchases of units of certain Funds" and the following text are inserted immediately before the subheading "Short-term trading" on page 23 of the Annual Information Form:
 - Effective April 7, 2016, units of the High Yield Bond Fund are no longer available for purchase by new investors. Investors who held units of the High Yield Bond Fund on April 7, 2016 can continue to make additional investments into the High Yield Bond Fund. Please contact us or your dealer for more information.
- 2. The subheading "Restrictions on purchases of units of certain Funds" is added to the Table of Contents on page 1 of the Annual Information Form accordingly under the heading "Purchases, switches and redemptions".
