

AMENDMENT NO. 1 dated October 2, 2018 to the annual information form dated June 28, 2018.

RBC PRIVATE POOLS Series F and Series O units RBC Private Canadian Growth and Income Equity Pool

(the *fund*)

This amendment no. 1 dated October 2, 2018 to the annual information form of the fund dated June 28, 2018 (the *annual information form*) provides certain additional information relating to the fund in conjunction with amendment no. 1 dated October 2, 2018 to the simplified prospectus of the fund dated June 28, 2018. The annual information form should be read subject to this information.

Summary

RBC GAM will continue to provide investment management oversight for the fund.

Amendments

The annual information form is hereby amended as follows:

(a) The row regarding the fund in the table under the subheading *Name, formation and history of the funds – RBC Private Pools – Canadian Equity* on page 12 of the annual information form is amended by replacing the words "Not applicable." in the column entitled "Changes" with the following:

On September 28, 2018, RBC GAM announced that it has begun a search to identify a replacement sub-advisor for the RBC Private Canadian Growth and Income Equity Pool. Greystone Managed Investments Inc. will continue its role as sub-advisor to the fund until another sub-advisor is identified, which RBC GAM anticipates will be no later than January 2019. RBC GAM will announce via press release who the replacement sub-advisor will be once this has been determined. RBC GAM will continue to provide investment management oversight for the fund.

(b) The row regarding the fund in the table under the subheading *Responsibility for operations of the funds – Investment sub-advisors* on page 42 of the annual information form is amended by inserting a footnote reference (new footnote 3) and the new footnote 3 is added to the bottom of the table on page 43, as follows:
