Investment Objective

This fund is an asset allocation fund designed to meet the needs of investors who are saving money towards their retirement, which they expect will commence around 2035. The fund invests primarily in equities until 10 years prior to retirement, at which point it gradually shifts its asset mix from an emphasis on equity funds to an emphasis on fixed income funds. Over the life of the fund, its portfolio will shift from a focus on funds with growth potential to a focus on funds that will preserve capital.

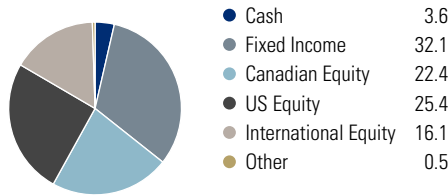

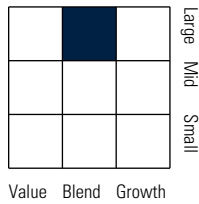

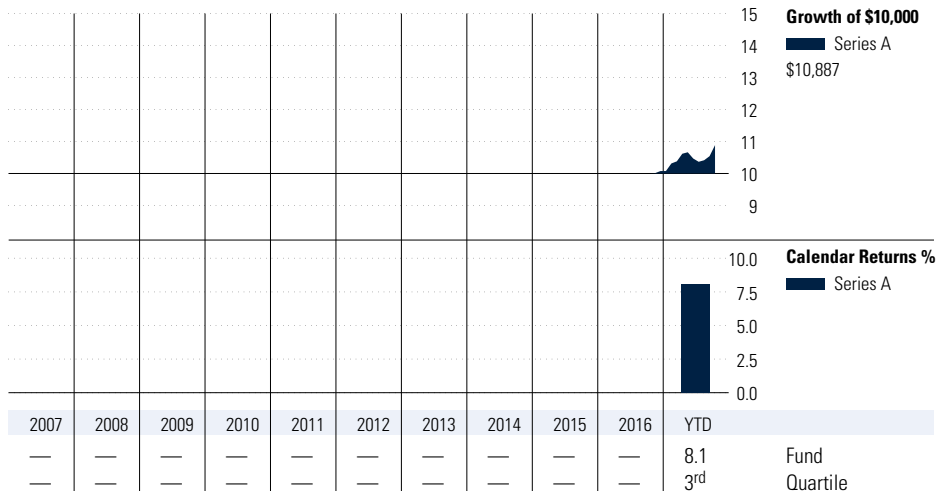

Quarterly Commentary as at September 30, 2017

RBC Retirement 2035 Portfolio was launched on October 11, 2016. Investment performance is not provided for a fund that has been available for less than one year.

Our models continue to suggest the long-term direction for bond yields is higher, which would

weigh on total returns for bond holders. Prospective returns for equities are much better than for fixed income, but the valuation tailwind from falling interest rates may be exhausted so earnings growth is now critical for the continuity of the bull market.
