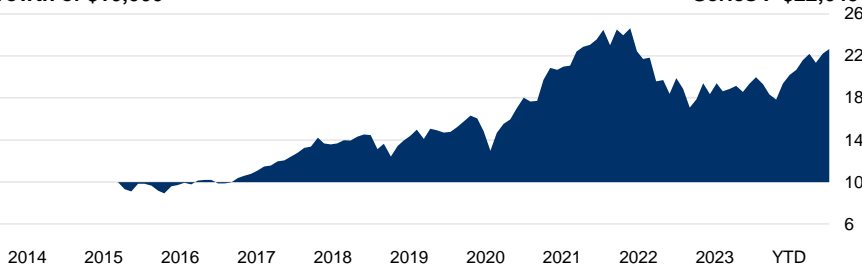

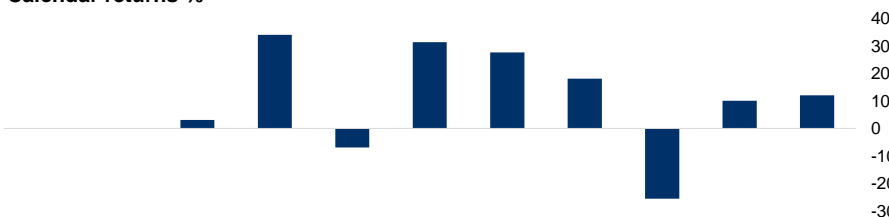
Performance analysis for Series F as of June 30, 2024
