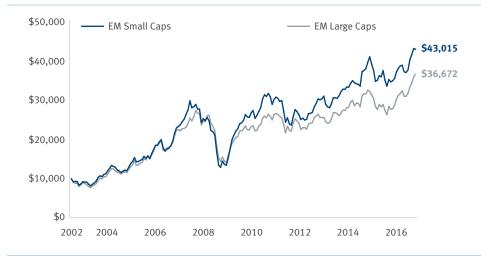

- Diversification benefits At different phases of the economic cycle, small- and largecap stocks can perform very differently from one another. Combining the appropriate amount of small- and large-cap equities in a portfolio can produce significant diversification benefits.
- The emerging markets small-cap anomaly While it is common in most markets for small-cap stocks to outperform large-cap stocks over the long term, they have generally done so with more volatility. However, over the past 15 years, small-cap emerging market equities have outperformed large-cap emerging market equities with slightly less volatility.
