What is socially responsible investing?

First, Jantzi Research employs its Best-of-Sector screening process to develop lists of stocks within each industry sector that pass the Jantzi environmental, social and governance screens. Next, RBC Asset Management applies its multi-disciplined security selection process to identify the securities that will make up each fund. The fund portfolios will be monitored on an ongoing basis to ensure the securities in the RBC Jantzi Funds continue to be Best-of-Sector.

Fund highlights

Three RBC Jantzi Funds are available and invest only in companies that rank highly in their industry sector, based on environmental, social and governance indicators:

RBC Jantzi Canadian Equity Fund provides exposure to equity investments within Canada. This fund is designed to provide long-term capital growth by investing primarily in stocks of major Canadian companies. The fund may also invest in companies outside of Canada.

RBC Jantzi Balanced Fund provides a diversified mix of equities and debt securities from around the world. Its objective is to provide capital growth, as well as moderate income. The fund invests primarily in stocks, bonds and short-term debt securities.

RBC Jantzi Global Equity Fund provides diversified exposure to equity investment opportunities outside of Canada. It invests primarily in equity securities of companies that operate in different countries around the world, across a range of industry sectors.

The Jantzi Research Best-of-Sector methodology is the most widely recognized screening process in the Canadian investment market. Screening for social responsibility and performance

A multi-step process ensures that the investments chosen for the RBC Jantzi Funds are Best-of-Sector in terms of social responsibility and have the greatest prospects for providing superior investment performance.



STEP 1**Social responsibility evaluation**

Jantzi Research analyzes a broad universe of stocks, using more than 100 indicators for environmental, social and governance performance.

STEP 2**Best-of-Sector methodology**

Based on the Jantzi Research analysis, stocks within each industry sector are sorted in order of performance. The screening process removes companies with poor environmental, social and/or governance practices, relative to their industry peers.

STEP 3**Financial analysis**

RBC Asset Management applies its multi-disciplined investment analysis to the best performers, focusing on above-average financial fundamentals while considering broader factors, such as economic trends, interest rates and the outlook for profits, valuations and stock prices.

STEP 4**The fund portfolio**

The result is a portfolio of funds that integrates the Jantzi Research social responsibility screening process with the investment expertise of RBC Asset Management to form the RBC Jantzi Funds.
