MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objective and Strategies

The Fund seeks to achieve a balance of income and long-term capital growth relative to its target retirement date of 2065 by investing primarily in investment funds that hold equity, fixed income, income trust and money market securities and exchange traded funds (“ETFs”), or by investing directly in such securities.

The Fund invests primarily in underlying funds. The Fund seeks to achieve its investment strategies by investing in two broad asset classes: equities and fixed income, either directly or indirectly through underlying funds and Canadian or U.S. ETFs. ETFs purchased by the Fund will initially be limited to those that track the investment performance of broad based real estate investment trust indices but may include other ETFs where permitted by applicable securities laws. At all times, the Fund will use a dynamic asset mix or glide path that adjusts the asset mix of the Fund on a quarterly basis relative to its target date.

Risk

There were no significant changes to the investment objective and strategies that affected the Fund’s overall level of risk during the reporting period. The risks of investing in the Fund and the suitability of the Fund for investors remain as discussed in the Simplified Prospectus.

Results of Operations

The Fund’s net asset value rose to \$572,000 as of December 31, 2025, from \$201,000 at the end of 2024. The increase was due mainly to net inflows.

Over the past year, the Fund’s Series F units gained 15.2%. The broad-based index 1 rose 2.6% and the broad-based index 2 rose 31.7%. The Fund’s return is after the deduction of fees and expenses, while benchmark and broad-based index returns do not include any costs of investing. See the Financial Highlights section for the management expense ratios and the Past Performance section for the returns of any other series, which may vary because of differences in management fees and expenses.

The global economy and financial markets largely withstood the impact of new U.S. trade barriers, as the positive impact of government stimulus and artificial intelligence (“AI”) on growth underpinned returns for the year as a whole. The announcement of higher tariffs in the first half of 2025 produced a temporary plunge in stocks and corporate bonds on concern that U.S. policy would curtail global growth. However, trade deals proved less punitive than had been feared, many central banks cut interest rates, and more companies began to benefit from the cost savings offered by AI. The

global expansion was also bolstered by capital expenditures related to building out the infrastructure required for AI, especially in the U.S. and China.

Canadian bonds rose for a third straight year as central banks extended interest-rate cuts amid a slowdown in domestic economic growth. The Bank of Canada (the “BOC”) lowered its benchmark interest rate by 1 percentage point to 2.25% in 2025, aiming to shield the weak economy from the threat of higher U.S. tariffs. The BOC also signalled that it had completed its current round of interest-rate reductions, leaving government spending to support the economic expansion. Investors were increasingly concerned about the outcome of next year’s renegotiation of Canada’s trade pact with the U.S. and Mexico, fearing that failure to reach a deal could exacerbate current economic strains. The U.S. Federal Reserve (the “Fed”) cut its benchmark interest rate by 0.75 percentage point in stages over the second half of 2025, bringing the benchmark rate down to a range of 3.50% to 3.75%. These rate reductions were aimed at stimulating growth and supporting a softening labour market. In December, the Fed announced an end to its bond-selling program to support the U.S. banking system and Treasuries. U.S. bonds outperformed their Canadian counterparts given expectations that the Fed would continue to reduce rates while the BOC stayed on hold. Returns in the fixed-income segment of the portfolio were boosted by the Phillips, Hager & North High Yield Bond Fund and the RBC High Yield Bond Fund.

Following a volatile start to 2025, equity markets ultimately found their footing and rewarded investors with strong returns in most major markets. In the U.S., equities were driven by AI and continued technological advances that led to increased investment in data centres, semiconductors and energy farms. Canadian stocks outperformed most major international indexes, led by gains in shares of precious-metals companies and financial firms. Gold producers as a group more than doubled, with bullion surging to records exceeding US\$4,300 during the period, due to geopolitical crises, concern about the independence of the Fed and U.S.-dollar weakness. Many European markets also hit record highs as the rise in the euro and significantly enhanced defence spending enabled regional stocks to outperform in Canadian- and U.S.-dollar terms. Emerging-market stocks recorded significant gains in 2025, beating developed markets for the first time in five years as the U.S. dollar weakened and Chinese equities rebounded from poor relative performance since the pandemic. Returns were bolstered by the Phillips, Hager & North Canadian Equity Underlying Fund and the Phillips, Hager & North Canadian Equity Value Fund.



Recent Developments

Economic growth should accelerate moderately in the year ahead, in the view of the portfolio manager, and may pleasantly surprise relative to consensus expectations. Tariff headwinds should fade, and important tailwinds are set to blow. Inflation may not fall by quite as much as consensus expectations for 2026 but should slowly ease after peaking in the spring.

An environment of moderate economic growth should allow inflation to subside sufficiently for continued interest-rate cuts by the Fed and foster strong corporate profit growth. Stocks are expected to continue outperforming bonds, but the portfolio manager recognizes that the potential for outsized gains has diminished following this year's strong performance that pushed some valuations to extreme levels. Against this backdrop, sovereign bonds should deliver cash-like returns and offer ballast against equity-market volatility should the economy disappoint.

Effective January 1, 2026, Brenda Eaton was appointed as Chair of the Independent Review Committee (the "IRC") following the retirement of Suromitra Sanatani, who has served as a dedicated member of the IRC since 2017. Effective January 1, 2026, Geoffrey D. Creighton was appointed as a new member of the IRC.

Effective January 1, 2025, the management fees for Series D units were reduced to 1.15% from 1.20% and for Series F units were reduced to 0.90% from 0.95%.

Related-Party Transactions

Manager and Portfolio Manager

RBC GAM is an indirect, wholly owned subsidiary of Royal Bank and is the manager and principal portfolio manager of the Fund. RBC GAM is responsible for the Fund's day-to-day operations, provides investment advice and portfolio management services to the Fund and appoints distributors for the Fund. RBC GAM is paid a management fee by the Fund as compensation for its services. The Fund pays a fixed administration fee to RBC GAM, which, in turn, pays certain operating expenses of the Fund. Both the management fee and fixed administration fee are calculated and accrued daily as a percentage of the net asset value of each series of units of the Fund.

RBC GAM or its affiliates may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, securities lending, foreign exchange and derivatives transactions. RBC GAM or its affiliates may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies. The Fund also maintains bank accounts and overdraft provisions with Royal Bank for which Royal Bank may earn a fee. Affiliates of RBC GAM that provide services to the Fund in the course of their normal businesses are discussed below.

Distributors

RBC GAM, Royal Mutual Funds Inc., RBC Direct Investing Inc., RBC Dominion Securities Inc. and Phillips, Hager & North Investment Funds Ltd. are principal distributors of, or may distribute certain series of units of, the Fund. Dealers may receive an ongoing commission based on the total value of their clients' investment in certain series of units of the Fund.

Registrars

RBC GAM, RBC Investor Services Trust ("RBC IS") or Royal Bank (or a combination thereof) are the registrars of the Fund and keep records of who owns units of the Fund. The registrars earn a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

Trustee and Custodian

RBC IS is the trustee and holds title to the Fund's property on behalf of unitholders. RBC IS is the custodian of the Fund and holds the assets of the Fund.

RBC IS earns a fee as the trustee and custodian, which is paid by the manager from the fixed administration fee paid by the Fund.

Securities Lending Agent

To the extent the Fund may engage in securities lending transactions, RBC IS may act as the Fund's securities lending agent. Any revenue earned on such securities lending is split between the Fund and the securities lending agent.

Other Related-Party Transactions

Pursuant to applicable securities legislation, the Fund relied on the standing instructions from the Independent Review Committee with respect to one or more of the following transactions:

Related-Party Trading Activities

- (a) trades in securities of Royal Bank;
- (b) investments in the securities of issuers for which a related-party dealer acted as an underwriter during the distribution of such securities and the 60-day period following the conclusion of such distribution of the underwritten securities to the public;
- (c) purchases of equity, debt securities or mortgages from or sales of equity, debt securities or mortgages to a related-party dealer, where it acted as principal; and

Inter-Fund Trading

- (d) purchases or sales of securities of an issuer from or to another investment fund or managed account managed by RBC GAM.



The applicable standing instructions require that Related-Party Trading Activities and Inter-Fund Trading be conducted in accordance with RBC GAM policy and that RBC GAM advise the Independent Review Committee of a material breach of any standing instruction. RBC GAM policy requires that an investment decision in respect of Related-Party Trading Activities (i) is made free from any influence of Royal Bank or its associates or affiliates and without taking into account any consideration relevant to Royal Bank or its affiliates or associates, (ii) represents the business judgment of the portfolio manager, uninfluenced by considerations other than the best interests of the Fund, (iii) is in compliance with RBC GAM policies and procedures, and (iv) achieves a fair and reasonable result for the Fund. RBC GAM policy requires that an investment decision in respect of Inter-Fund Trading is in the best interests of each Fund.

¹ The management expense ratio ("MER") is based on the direct expenses charged to the Fund and the Fund's proportionate share of the expenses of underlying funds, if any, for the stated period, excluding commissions and other portfolio transaction costs, and is expressed as an annualized percentage of the daily average net asset value during the period. RBC GAM may, at its discretion and without notice to unitholders, waive or absorb certain operating expenses. MER includes the waiver or absorption by RBC GAM of certain operating expenses, while the MER before absorption shows the MER prior to operating expenses being waived or absorbed by RBC GAM.

² The Fund's portfolio turnover rate gives an indication of the level of activity employed by the portfolio manager. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund. The portfolio turnover rate is not applicable to money market funds.

³ The trading expense ratio represents total commissions and other portfolio transaction costs of the Fund and the Fund's proportionate share of such costs of underlying funds expressed as an annualized percentage of daily average net asset value during the period. The trading expense ratio is not applicable to fixed-income transactions.

Effective January 1, 2025, the management fees for Series D units were reduced to 1.15% from 1.20% and for Series F units were reduced to 0.90% from 0.95%. If the changes to the management fees would have been in effect throughout the financial year ended December 31, 2024, the adjusted MER for each series of the Fund would be: Series D – 1.39% and Series F – 1.11%.

Management Fees and Administration Fees

Management fees and administration fees of each series of the Fund are payable to RBC GAM and calculated at the following annual percentages, before GST/HST, of the daily net asset value of each series of the Fund. The management fee, breakdown of services received in consideration of the management fee, as a percentage of the management fee, and the administration fee for each series are as follows:

Series O – no management fees are paid by the Fund with respect to Series O units. Series O unitholders pay a negotiated fee directly to RBC GAM for investment-counselling services.

* Effective January 1, 2025, the management fees for Series D units were reduced to 1.15% from 1.20% and for Series F units were reduced to 0.90% from 0.95%. Effective January 1, 2030, the management fees for Series D units will be reduced to 1.10% from 1.15% and for Series F units will be reduced to 0.85% from 0.90%. Effective January 1, 2035, the management fees for Series D units will be reduced to 1.05% from 1.10% and for Series F units will be reduced to 0.80% from 0.85%. Effective January 1, 2040, the management fees for Series D units will be reduced to 1.00% from 1.05% and for Series F units will be reduced to 0.75% from 0.80%. Effective January 1, 2045, the management fees for Series D units will be reduced to 0.95% from 1.00% and for Series F units will be reduced to 0.70% from 0.75%. Effective January 1, 2050, the management fees for Series D units will be reduced to 0.90% from 0.95% and for Series F units will be reduced to 0.65% from 0.70%. Effective January 1, 2055, the management fees for Series D units will be reduced to 0.85% from 0.90% and for Series F units will be reduced to 0.60% from 0.65%. Effective January 1, 2060, the management fees for Series D units will be reduced to 0.80% from 0.85% and for Series F units will be reduced to 0.55% from 0.60%. Effective January 1, 2065, the management fees for Series D units will be reduced to 0.75% from 0.80% and for Series F units will be reduced to 0.50% from 0.55%.

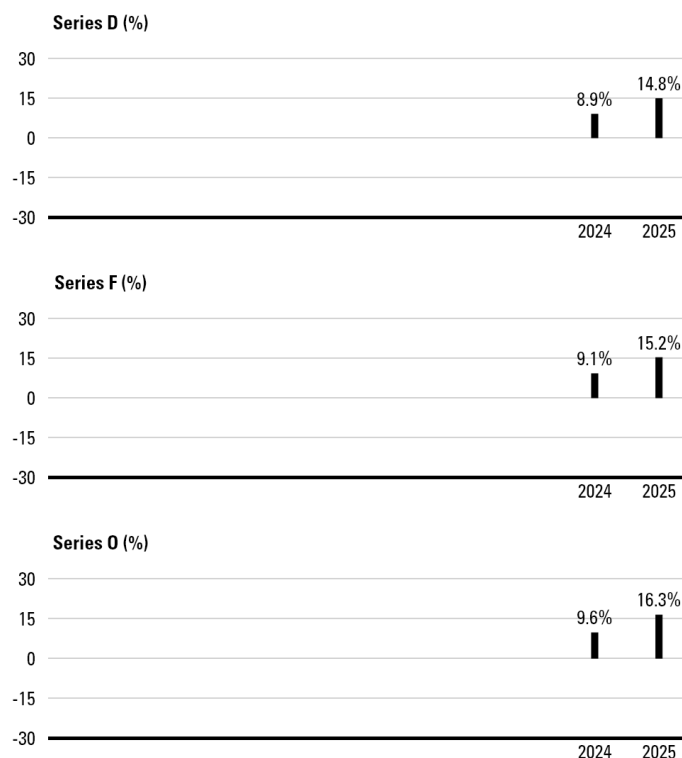
