## MANAGEMENT DISCUSSION OF FUND PERFORMANCE

### Investment Objective and Strategies

The Fund seeks to provide long-term capital growth by investing primarily in equity securities of companies located or active in emerging markets, but excludes securities of issuers directly engaged in the extraction, processing and transportation of fossil fuels such as coal, oil and natural gas.

The Fund's investment process begins by excluding issuers identified in two exclusion lists that determine its investable universe. The Fund applies the two exclusion lists concurrently. The Fund may from time to time depart from its exclusion lists when RBC GAM has determined that it would be in the best interest of the Fund to do so.

The first exclusion list is based on the Carbon Underground 200, which identifies the top 100 public coal companies globally and the top 100 public oil and gas companies globally, ranked by the potential carbon emissions content of their reported reserves. The Carbon Underground 200 list is maintained by Fossil Free Indexes LLC, and is revised quarterly.

With respect to the second exclusion list, Sustainalytics determines and excludes companies that directly, or indirectly through a significant stake in a subsidiary, derive any revenues from or are involved in the (i) exploration and extraction of Arctic oil and gas, (ii) exploration, production, refining, transportation and/or storage of oil and natural gas, (iii) extraction of oil sands, shale energy and/or thermal coal, and/or (iv) provision of storage, transportation, mining and refining services of thermal coal. The Fund also excludes companies that directly, or indirectly through a significant stake in a subsidiary, derive 10% or more of their revenues from the provision of tailor-made products and services that support oil and gas exploration, production, refining, transportation and/or storage, or from power generated by thermal coal, as determined by Sustainalytics.

On a monthly basis, Sustainalytics provides RBC GAM with a list of ineligible issuers based on the Fund's exclusion criteria. Sustainalytics periodically monitors the Fund's holdings against the exclusion criteria.

RBC GAM then applies its multi-disciplined investment process to select securities for the Fund. This includes the incorporation of environmental, social and governance ("ESG") factors to the extent that an issuer's management and exposure to such ESG factors are material to the risk-adjusted long-term performance of the security and/or the Fund.

### Risk

There were no significant changes to the investment objective and strategies that affected the Fund's overall level of risk during the reporting period. The risks of investing in the Fund and the suitability of the Fund for investors remain as discussed in the Simplified Prospectus.

### Results of Operations

The Fund's net asset value rose to \$153 million as of December 31, 2024, from \$93 million at the end of 2023. The increase was due to a combination of net inflows and investment returns.

Over the past year, the Fund's Series F units gained 16.5%, which underperformed the 18.1% rise in the benchmark. The broad-based index rose 17.3%. The Fund's return is after the deduction of fees and expenses, while benchmark and broad-based index returns do not include any costs of investing. See the Financial Highlights section for the management expense ratios and the Past Performance section for the returns of any other series, which may vary because of differences in management fees and expenses.

Emerging-market equities posted attractive returns in 2024 as Taiwan's stock index benefited from exposure to advances in artificial intelligence, and Chinese markets rallied to their best performance since 2020 after the government announced aggressive stimulus plans to bolster anemic economic growth. India, the third-largest emerging market after China, also offered attractive returns. However, emerging-market stocks lagged developed markets, extending more than a decade of underperformance, as the U.S. dollar appreciated versus emerging-market currencies.

The Fund's relative returns benefited from stock selection in the Information Technology and Real Estate sectors, as well as the absence in the portfolio of stocks in the Energy sector. The Fund also benefited from particularly strong stock selection in South Korea, while investment choices in China had a negative impact.

The top-performing allocations during the period were Samsung Electronics; Phoenix Mills; Tencent Holdings; and Discovery Ltd. Allocations that had a negative impact were Fomento Económico Mexicano; Raia Drogasil; B3 SA; Samsung Electronics; Meituan; and AIA Group. The Fund benefited from the absence of PDD Holdings in the portfolio.

Sustainalytics conducted a review covering the Fund's holdings in 2024. In the opinion of Sustainalytics and RBC GAM, all holdings in the Fund were eligible in the latest review based on the Fund's ESG exclusion criteria. During 2024, no companies were removed from the Fund for failing to meet the ESG exclusion criteria.



### **Recent Developments**

There are two major factors supporting emerging-market equities over the medium term. First, earnings and economic growth are poised to improve from the low levels of the past few years, driven by rising productivity, structural reforms and growth-friendly fiscal policies. Second, emerging-market stocks are attractively valued, particularly relative to developed markets, following their significant underperformance.

The sub-advisor also believes that emerging markets increasingly offer the critical mass necessary for investors seeking to diversify their holdings away from developed markets. At the country level, this trend is evidenced by the fact that China weight in the emerging-market benchmark continues to fall, declining to about 28% at the end of 2024 from its peak of 41% in 2021. India's weight has increased to 19.4% from 9.3% at the end of 2020, and the combined weight of Saudi Arabia, Qatar and Kuwait has grown to 7.2% from 4.2% in that period.

### **Related-Party Transactions**

#### ***Manager, Trustee and Portfolio Manager***

RBC GAM is an indirect, wholly owned subsidiary of Royal Bank of Canada ("Royal Bank") and is the manager, trustee and portfolio manager of the Fund. RBC GAM is responsible for the Fund's day-to-day operations, holds title to the Fund's property on behalf of its unitholders, provides investment advice and portfolio management services to the Fund and appoints distributors for the Fund. RBC GAM is paid a management fee by the Fund as compensation for its services. The Fund pays a fixed administration fee to RBC GAM, which, in turn, pays certain operating expenses of the Fund. Both the management fee and fixed administration fee are calculated and accrued daily as a percentage of the net asset value of each series of units of the Fund. RBC GAM, as trustee, earns a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

RBC GAM or its affiliates may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, securities lending, foreign exchange and derivatives transactions. RBC GAM or its affiliates may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies. The Fund also maintains bank accounts and overdraft provisions with Royal Bank for which Royal Bank may earn a fee. Affiliates of RBC GAM that provide services to the Fund in the course of their normal businesses are discussed below.

### ***Sub-Advisor***

RBC Global Asset Management (UK) Limited is the sub-advisor and provides investment advice for the Fund. The sub-advisor earns a fee which is calculated and accrued daily as a percentage of the net asset value of each series of units of the Fund. The sub-advisor is paid by the manager from the management fee paid by the Fund.

### ***Distributors***

RBC GAM, Royal Mutual Funds Inc., RBC Direct Investing Inc., RBC Dominion Securities Inc. and Phillips, Hager & North Investment Funds Ltd. are principal distributors of, or may distribute certain series of units of, the Fund. Dealers may receive an ongoing commission based on the total value of their clients' investment in certain series of units of the Fund.

### ***Registrars***

RBC GAM, RBC Investor Services Trust ("RBC IS") or Royal Bank (or a combination thereof) are the registrars of the Fund and keep records of who owns units of the Fund. The registrars earn a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

### ***Custodian***

RBC IS is the custodian and holds the assets of the Fund. RBC IS earns a fee as the custodian, which is paid by the manager from the fixed administration fee paid by the Fund.

### ***Securities Lending Agent***

To the extent the Fund may engage in securities lending transactions, RBC IS may act as the Fund's securities lending agent. Any revenue earned on such securities lending is split between the Fund and the securities lending agent.

### ***Other Related-Party Transactions***

Pursuant to applicable securities legislation, the Fund relied on the standing instructions from the Independent Review Committee with respect to one or more of the following transactions:

#### ***Related-Party Trading Activities***

- (a) trades in securities of Royal Bank;
- (b) investments in the securities of issuers for which a related-party dealer acted as an underwriter during the distribution of such securities and the 60-day period following the conclusion of such distribution of the underwritten securities to the public;
- (c) purchases of equity, debt securities or mortgages from or sales of equity, debt securities or mortgages to a related-party dealer, where it acted as principal; and

#### ***Inter-Fund Trading***

- (d) purchases or sales of securities of an issuer from or to another investment fund or managed account managed by RBC GAM.



The applicable standing instructions require that Related-Party Trading Activities and Inter-Fund Trading be conducted in accordance with RBC GAM policy and that RBC GAM advise the Independent Review Committee of a material breach of any standing instruction. RBC GAM policy requires that an investment decision in respect of Related-Party Trading Activities (i) is made free from any influence of Royal Bank or its associates or affiliates and without taking into account any consideration relevant to Royal Bank or its affiliates or associates, (ii) represents the business judgment of the portfolio manager, uninfluenced by considerations other than the best interests of the Fund, (iii) is in compliance with RBC GAM policies and procedures, and (iv) achieves a fair and reasonable result for the Fund. RBC GAM policy requires that an investment decision in respect of Inter-Fund Trading is in the best interests of each Fund.

### Management Fees and Administration Fees

Management fees and administration fees of each series of the Fund are payable to RBC GAM and calculated at the following annual percentages, before GST/HST, of the daily net asset value of each series of the Fund. The management fee, breakdown of services received in consideration of the management fee, as a percentage of the management fee, and the administration fee for each series are as follows:

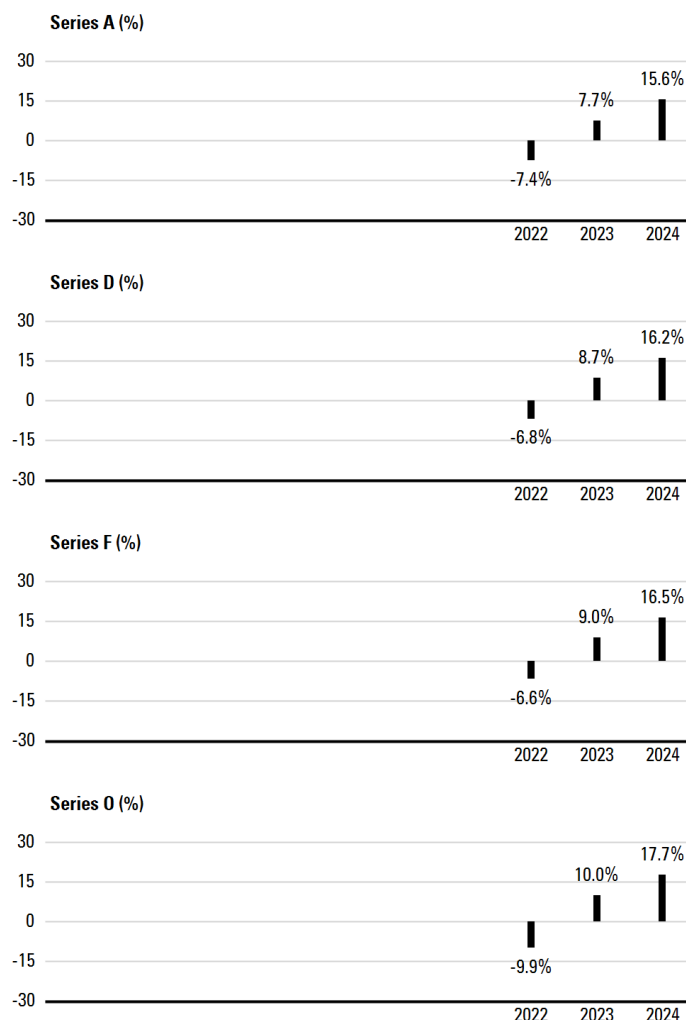

### INDEX DESCRIPTIONS

**MSCI Emerging Markets ex-Fossil Fuel Total Return Net Index (CAD)** The index is a broad performance measure of large- and mid-cap stocks in emerging markets, excluding companies that own oil, gas and coal reserves. It is a benchmark for investors who aim to eliminate investment exposure to fossil-fuel reserves due to concerns about their contribution to climate change.

**MSCI Emerging Markets Total Return Net Index (CAD)** This index is a broad measure of the Canadian-dollar performance of emerging-market equities. As of May 2010, the index consisted of the following 21 emerging-market country indexes: Brazil, Chile, China, Colombia, Czech Republic, Egypt, Hungary, India, Indonesia, Malaysia, Mexico, Morocco, Peru, Philippines, Poland, Russia, South Africa, South Korea, Taiwan, Thailand and Turkey. The net total return index reinvests dividends after the deduction of withholding taxes, using (for international indexes) a tax rate applicable to non-resident institutional investors who do not benefit from double taxation treaties.
