## MANAGEMENT DISCUSSION OF FUND PERFORMANCE

### Investment Objective and Strategies

The Fund seeks to provide current income and stability of capital by investing primarily in a well-diversified portfolio of short-term fixed-income securities issued by Canadian governments and corporations, but excludes securities of issuers directly engaged in the extraction, processing and transportation of fossil fuels such as coal, oil and natural gas.

The Fund's investment process begins by excluding issuers identified in two exclusion lists that determine its investable universe. The Fund applies the two exclusion lists concurrently. The Fund may from time to time depart from its exclusion lists when RBC GAM has determined that it would be in the best interest of the Fund to do so.

The first exclusion list is based on the Carbon Underground 200, which identifies the top 100 public coal companies globally and the top 100 public oil and gas companies globally, ranked by the potential carbon emissions content of their reported reserves. The Carbon Underground 200 list is maintained by Fossil Free Indexes LLC, and is revised quarterly.

With respect to the second exclusion list, Sustainalytics determines and excludes companies that directly, or indirectly through a significant stake in a subsidiary, derive any revenues from or are involved in the (i) exploration and extraction of Arctic oil and gas, (ii) exploration, production, refining, transportation and/or storage of oil and natural gas, (iii) extraction of oil sands, shale energy and/or thermal coal, and/or (iv) provision of storage, transportation, mining and refining services of thermal coal. The Fund also excludes companies that directly, or indirectly through a significant stake in a subsidiary, derive 10% or more of their revenues from the provision of tailor-made products and services that support oil and gas exploration, production, refining, transportation and/or storage, or from power generated by thermal coal, as determined by Sustainalytics.

On a monthly basis, Sustainalytics provides RBC GAM with a list of ineligible issuers based on the Fund's exclusion criteria. Sustainalytics periodically monitors the Fund's holdings against the exclusion criteria.

RBC GAM then applies its multi-disciplined investment process to select securities for the Fund. This includes the incorporation of environmental, social and governance ("ESG") factors to the extent that an issuer's management of and exposure to such ESG factors are material to the risk-adjusted long-term performance of the security and/or the fund.

### Risk

There were no significant changes to the investment objective and strategies that affected the Fund's overall level of risk during the reporting period. The risks of investing in the Fund and the suitability of the Fund for investors remain as discussed in the Simplified Prospectus.

### Results of Operations

The Fund's net asset value rose to \$483 million as of December 31, 2025, from \$404 million at the end of 2024. The increase was due to a combination of net inflows and investment returns.

Over the past year, the Fund's Series F units gained 3.6%, which underperformed the 3.9% rise in the benchmark. The Fund's return is after the deduction of fees and expenses, while benchmark and broad-based index returns do not include any costs of investing. See the Financial Highlights section for the management expense ratios and the Past Performance section for the returns of any other series, which may vary because of differences in management fees and expenses.

Returns on short-term Canadian bonds rose amid interest-rate cuts as domestic economic growth remained weak. The Bank of Canada (the "BOC") balanced concerns of slower economic growth linked in part to an evolving trade war with the U.S. against the threat of higher inflation. In this environment, the BOC reduced its key policy interest rate by 1 percentage point to 2.25% over the course of 2025, pushing down yields on short-term Government of Canada ("GOC") bonds and resulting in higher prices. Investors were wary about increases in government spending to prop up the economy, and the growing government deficits that come with such increases. Canada, like many other countries, is boosting expenditures on infrastructure and defence to offset weak private investment.

The Fund's sensitivity to interest rates was actively managed during a volatile period for bond yields, and this approach had a negative impact on the portfolio's overall performance. The portfolio manager's continued preference for provincial bonds, government-backed housing bonds, investment-grade corporate bonds and commercial multi-residential mortgages contributed to the Fund's performance. These strategies produced higher income earned on similar-term "risk-free" GOC bonds.

Portfolio turnover is normally high for the Fund, as the portfolio manager attempts to generate better returns through active security selection and optimal term exposure.



Sustainalytics conducted reviews covering the Fund's holdings in 2025. In the opinion of Sustainalytics and RBC GAM, all holdings in the Fund were eligible at the time of review based on the Fund's ESG exclusion criteria. During 2025, no holdings were removed from the Fund for failing to meet the ESG exclusion criteria.

#### **Recent Developments**

The portfolio manager remains cautious given relatively high valuations and concerns about trade-related uncertainty and its potential impact on the Canadian economy. The portfolio manager continues, therefore, to favour higher-quality parts of the market that position the Fund to withstand market weakness and is ready to take advantage of attractive opportunities as they arise.

The combined federal and provincial deficits for the next fiscal year is expected to total approximately 4% of Canada's GDP, one of the largest levels since the early 1990s outside the COVID-19 period and the global financial crisis.

Effective January 1, 2026, Brenda Eaton was appointed as Chair of the Independent Review Committee (the "IRC") following the retirement of Suromitra Sanatani, who has served as a dedicated member of the IRC since 2017. Effective January 1, 2026, Geoffrey D. Creighton was appointed as a new member of the IRC.

#### **Related-Party Transactions**

##### ***Manager, Trustee and Portfolio Manager***

RBC GAM is an indirect, wholly owned subsidiary of Royal Bank of Canada ("Royal Bank") and is the manager, trustee and portfolio manager of the Fund. RBC GAM is responsible for the Fund's day-to-day operations, holds title to the Fund's property on behalf of its unitholders, provides investment advice and portfolio management services to the Fund and appoints distributors for the Fund. RBC GAM is paid a management fee by the Fund as compensation for its services. The Fund pays a fixed administration fee to RBC GAM, which, in turn, pays certain operating expenses of the Fund. Both the management fee and fixed administration fee are calculated and accrued daily as a percentage of the net asset value of each series of units of the Fund. RBC GAM, as trustee, earns a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

RBC GAM or its affiliates may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, securities lending, foreign exchange and derivatives transactions. RBC GAM or its affiliates may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies. The Fund also maintains bank accounts and overdraft provisions with Royal Bank for which Royal Bank may earn a fee. Affiliates of RBC GAM that provide services to the Fund in the course of their normal businesses are discussed below.

##### ***Distributors***

RBC GAM, Royal Mutual Funds Inc., RBC Direct Investing Inc., RBC Dominion Securities Inc. and Phillips, Hager & North Investment Funds Ltd. are principal distributors of, or may distribute certain series of units of, the Fund. Dealers may receive an ongoing commission based on the total value of their clients' investment in certain series of units of the Fund.

##### ***Registrars***

RBC GAM, RBC Investor Services Trust ("RBC IS") or Royal Bank (or a combination thereof) are the registrars of the Fund and keep records of who owns units of the Fund. The registrars earn a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

##### ***Custodian***

RBC IS is the custodian and holds the assets of the Fund. RBC IS earns a fee as the custodian, which is paid by the manager from the fixed administration fee paid by the Fund.

##### ***Securities Lending Agent***

To the extent the Fund may engage in securities lending transactions, RBC IS may act as the Fund's securities lending agent. Any revenue earned on such securities lending is split between the Fund and the securities lending agent.

##### ***Other Related-Party Transactions***

Pursuant to applicable securities legislation, the Fund relied on the standing instructions from the Independent Review Committee with respect to one or more of the following transactions:

##### ***Related-Party Trading Activities***

- (a) trades in securities of Royal Bank;
- (b) investments in the securities of issuers for which a related-party dealer acted as an underwriter during the distribution of such securities and the 60-day period following the conclusion of such distribution of the underwritten securities to the public;
- (c) purchases of equity, debt securities or mortgages from or sales of equity, debt securities or mortgages to a related-party dealer, where it acted as principal; and

##### ***Inter-Fund Trading***

- (d) purchases or sales of securities of an issuer from or to another investment fund or managed account managed by RBC GAM.



The applicable standing instructions require that Related-Party Trading Activities and Inter-Fund Trading be conducted in accordance with RBC GAM policy and that RBC GAM advise the Independent Review Committee of a material breach of any standing instruction. RBC GAM policy requires that an investment decision in respect of Related-Party Trading Activities (i) is made free from any influence of Royal Bank or its associates or affiliates and without taking into account any consideration relevant to Royal Bank or its affiliates or associates, (ii) represents the business judgment of the portfolio manager, uninfluenced by considerations other than the best interests of the Fund, (iii) is in compliance with RBC GAM policies and procedures, and (iv) achieves a fair and reasonable result for the Fund. RBC GAM policy requires that an investment decision in respect of Inter-Fund Trading is in the best interests of each Fund.

<sup>2</sup> The Fund's portfolio turnover rate gives an indication of the level of activity employed by the portfolio manager. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund. The portfolio turnover rate is not applicable to money market funds.

Effective January 25, 2021, the administration fees for Series O units were reduced to 0.02% from 0.05%. If the changes to the administration fees would have been in effect throughout the financial year ended December 31, 2021, the adjusted MER for each series of the Fund would be: Series O – 0.02%.

### Management Fees and Administration Fees

Management fees and administration fees of each series of the Fund are payable to RBC GAM and calculated at the following annual percentages, before GST/HST, of the daily net asset value of each series of the Fund. 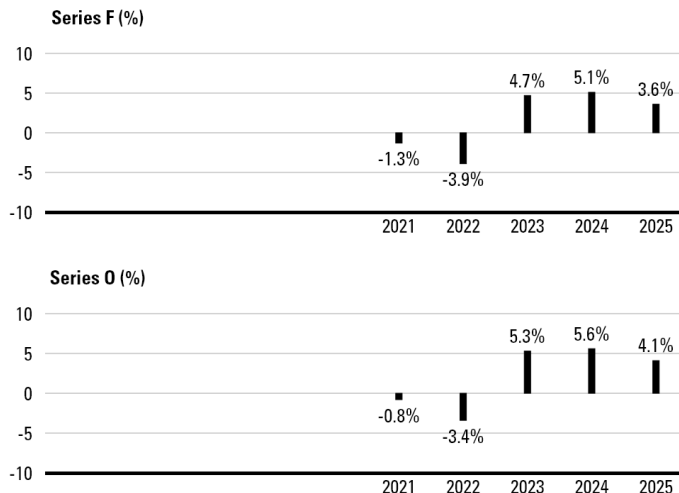
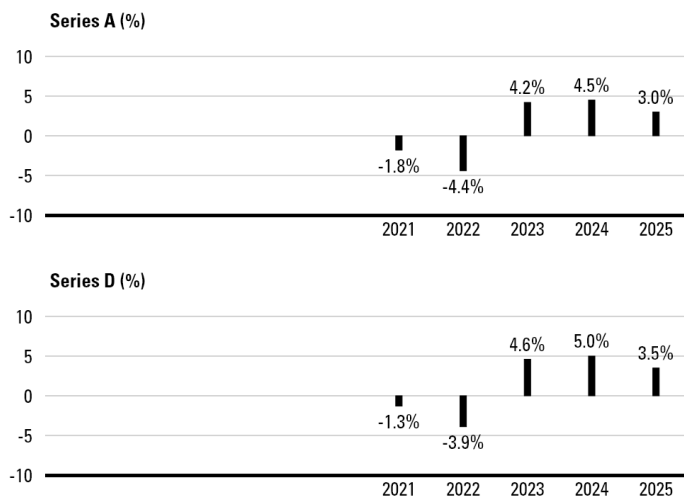


### PAST PERFORMANCE
