## MANAGEMENT DISCUSSION OF FUND PERFORMANCE

### Investment Objective and Strategies

The Fund seeks to provide long-term capital growth by tracking the performance of the S&P 500 Total Return Hedged 100% to CAD Index and investing primarily in units of the iShares Core S&P 500 Index ETF (the “underlying fund”). The Fund employs strategies to minimize the effect on the Fund of currency fluctuations in the value of the U.S. dollar relative to the Canadian dollar. The Fund may also invest in the iShares Core S&P 500 Index ETF (CAD-Hedged).

### Risk

There were no significant changes to the investment objective and strategies that affected the Fund’s overall level of risk during the reporting period. The risks of investing in the Fund and the suitability of the Fund for investors remain as discussed in the Simplified Prospectus.

### Results of Operations

The Fund’s net asset value fell to \$514 million as of December 31, 2022, from \$603 million at the end of 2021. The decrease was due to investment losses.

Over the past year, the Fund’s Series F units lost 18.9%, which outperformed the 19.2% decline in the benchmark. The Fund’s return is after the deduction of fees and expenses, while benchmark and broad-based index returns do not include any costs of investing. See the Financial Highlights section for the management expense ratios and the Past Performance section for the returns of any other series, which may vary because of differences in management fees and expenses.

U.S. stocks declined in 2022, recording their worst drop since 2008, given inflation at a 40-year high and a concurrent sharp rise in interest rates. The S&P 500 Index started 2022 at a record high but came under pressure in the first quarter of the year after it became clear that inflation initially called “transitory” by the U.S. Federal Reserve (the “Fed”) would be higher and last longer than the U.S. central bank had anticipated. To tame inflation, which in June peaked at 9.1% – more than four times the Fed’s target of 2% – the Fed embarked on its fastest round of rate hikes since the early 1980s, taking the policy rate from near zero to 4.5% in just nine months. Rising interest rates and the expectations that economic growth would slow weighed on stock valuations in all sectors except Energy, which was supported by higher oil prices.

### Recent Developments

Effective September 20, 2022, Brenda Eaton was appointed as Vice Chair of the Independent Review Committee (the “IRC”) following the death of Paul K. Bates, who had served as a

dedicated member of the IRC since December 2014. Effective December 31, 2022, Charles F. Macfarlane stepped down as a member of the IRC, and effective January 1, 2023, Suromitra Sanatani was appointed as Chair of the IRC.

Effective January 24, 2022, the Fund’s name was changed to RBC U.S. Equity Currency Neutral Index ETF Fund.

Effective January 24, 2022, all outstanding Series A units were re-designated as Series DZ units.

Effective January 21, 2022, Series A units of the Fund are capped and are no longer available for purchase by new investors. Existing investors who hold Series A units of the Fund can continue to make additional investments into this series.

### Related-Party Transactions

#### *Manager, Trustee and Portfolio Manager*

RBC GAM is an indirect, wholly owned subsidiary of Royal Bank of Canada (“Royal Bank”) and is the manager, trustee and portfolio manager of the Fund. RBC GAM is responsible for the Fund’s day-to-day operations, holds title to the Fund’s property on behalf of its unitholders, provides investment advice and portfolio management services to the Fund and appoints distributors for the Fund. RBC GAM is paid a management fee by the Fund as compensation for its services. The Fund pays a fixed administration fee to RBC GAM, which, in turn, pays certain operating expenses of the Fund. Both the management fee and fixed administration fee are calculated and accrued daily as a percentage of the net asset value of each series of units of the Fund. RBC GAM, as trustee, earns a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

RBC GAM or its affiliates may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, securities lending, foreign exchange and derivatives transactions. RBC GAM or its affiliates may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies. The Fund also maintains bank accounts and overdraft provisions with Royal Bank for which Royal Bank may earn a fee. Affiliates of RBC GAM that provide services to the Fund in the course of their normal businesses are discussed below.

#### *Distributors*

RBC GAM, Royal Mutual Funds Inc., RBC Direct Investing Inc., RBC Dominion Securities Inc. and Phillips, Hager & North Investment Funds Ltd. are principal distributors of, or may distribute certain series of units of, the Fund. Dealers may receive an ongoing commission based on the total value of their clients’ investment in certain series of units of the Fund.



**Registrars**

RBC GAM, RBC Investor Services Trust ("RBC IS") or Royal Bank (or a combination thereof) are the registrars of the Fund and keep records of who owns units of the Fund. The registrars earn a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

**Custodian**

RBC IS is the custodian and holds the assets of the Fund. RBC IS earns a fee as the custodian, which is paid by the manager from the fixed administration fee paid by the Fund.

**Securities Lending Agent**

To the extent the Fund may engage in securities lending transactions, RBC IS may act as the Fund's securities lending agent. Any revenue earned on such securities lending is split between the Fund and the securities lending agent.

**Brokers and Dealers**

The Fund has established standard brokerage and dealing agreements at market rates with related parties. For the periods ended December 31, 2022 and 2021, the related-party commissions were \$2,000 (2021 – \$0) or 18% (2021 – 0%) of the total transaction costs paid for this Fund.

**Other Related-Party Transactions**

Pursuant to applicable securities legislation, the Fund relied on the standing instructions from the Independent Review Committee with respect to one or more of the following transactions:

*Related-Party Trading Activities*

- (a) trades in securities of Royal Bank;
- (b) investments in the securities of issuers for which a related-party dealer acted as an underwriter during the distribution of such securities and the 60-day period following the conclusion of such distribution of the underwritten securities to the public;
- (c) purchases of equity and debt securities from or sales of equity or debt securities to a related-party dealer, where it acted as principal; and

*Inter-Fund Trading*

- (d) purchases or sales of securities of an issuer from or to another investment fund or managed account managed by RBC GAM.

The applicable standing instructions require that Related-Party Trading Activities and Inter-Fund Trading be conducted in accordance with RBC GAM policy and that RBC GAM advise the Independent Review Committee of a material breach of any standing instruction. RBC GAM policy requires that an investment decision in respect of Related-Party Trading Activities (i) is made free from any influence of Royal Bank or its associates or affiliates and without taking into account any consideration relevant to Royal Bank or its affiliates or associates, (ii) represents the business judgment of the portfolio manager, uninfluenced by considerations other than the best interests of the Fund, (iii) is in compliance with RBC GAM policies and procedures, and (iv) achieves a fair and reasonable result for the Fund. RBC GAM policy requires that an investment decision in respect of Inter-Fund Trading is in the best interests of each Fund.

<sup>2</sup> The Fund's portfolio turnover rate gives an indication of the level of activity employed by the portfolio manager. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund. The portfolio turnover rate is not applicable to money market funds.

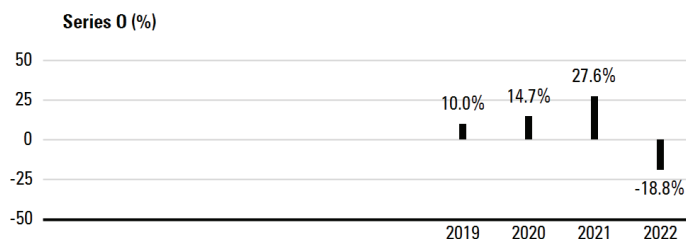
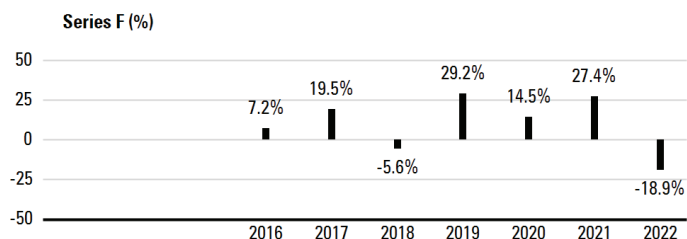
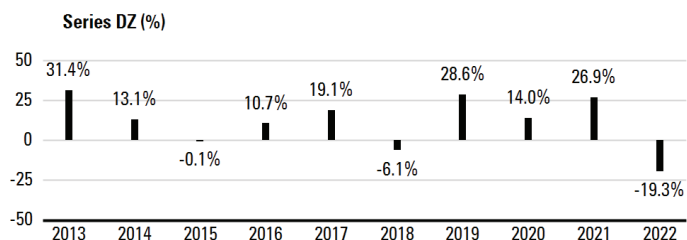


### PAST PERFORMANCE

The index gives investors a broad measure of the overall performance of the U.S. stock market and is hedged to Canadian dollars.
