## MANAGEMENT DISCUSSION OF FUND PERFORMANCE

## **Investment Objective and Strategies**

The Fund seeks to provide long-term total returns through capital appreciation by investing in a diversified portfolio of equity securities of companies operating in various countries around the world. The Fund invests in a more concentrated portfolio of securities primarily in mid- to large-cap stocks.

To achieve its objective, the Fund invests in companies that exhibit above-average earnings growth rate with strong and/or improving financial performance. The Fund may invest no more than 20% of its assets in securities of companies domiciled in emerging markets.

#### Risk

There were no significant changes to the investment objective and strategies that affected the Fund's overall level of risk during the reporting period. The risks of investing in the Fund and the suitability of the Fund for investors remain as discussed in the Simplified Prospectus.

# **Results of Operations**

The Fund's net asset value rose to \$67 million as of December 31, 2024, from \$57 million at the end of 2023. The increase was due to investment returns.

Over the past year, the Fund's Series F units gained 16.4%, which underperformed the 29.4% rise in the benchmark. The Fund's return is after the deduction of fees and expenses, while benchmark and broad-based index returns do not include any costs of investing. See the Financial Highlights section for the management expense ratios and the Past Performance section for the returns of any other series, which may vary because of differences in management fees and expenses.

Global equity markets climbed during 2024, with the prospect of lower interest rates and signs of global economic resilience fuelling investor optimism. A key feature of much of the period was the concentration of U.S. market returns, with the "Magnificent 7," which includes companies such as Apple Inc. and Nvidia, at the forefront of market gains.

Against this backdrop, the portfolio's holdings in the Information Technology sector had the largest negative impact on relative returns. Adobe, a U.S. maker of imaging software, was a notable drag on performance, with investors concerned about the pace of the company's progress in harnessing opportunities from artificial intelligence ("AI"). The Fund's returns were bolstered by Taiwan Semiconductor, a chipmaker whose products are used in AI infrastructure; Fortinet, a cybersecurity company; and Amphenol, which makes electronic connectors.

Other sectors that had a negative impact on the Fund's performance were Industrials, Financials and Consumer Discretionary. Returns were hurt by exposure to Ferguson Enterprises, a U.S.-based distributor of plumbing and construction products, and SMC, a Japanese maker of pneumatic equipment used in automation, reflecting weak global manufacturing activity. The Financials sector also hurt the Fund's returns, due mainly to the underperformance of the insurance companies AIA and Prudential Plc given weak business conditions in China. Shares of Nike, the maker of athletic shoes and casual footwear, fell amid strategic mistakes, and the company replaced its CEO.

The portfolio's returns were aided by a lack of exposure to the underperforming Energy and Real Estate sectors. The Health Care sector aided returns on a relative basis in part due to a holding in Intuitive Surgical, which makes products for robotic surgery. The portfolio's positioning remained unchanged over the period given the Fund's focus on long-term stock-picking, rather than investment decisions based on sector or benchmark considerations.

## **Recent Developments**

The view of many investors is that global economic growth will slow in the coming months, but not enough to result in a recession. Slower inflation, further interest-rate cuts by the U.S. Federal Reserve and the European Central Bank and the continued resilience of consumer spending are expected to support growth. While the fiscal policies of President-elect Trump are likely to spur economic growth, his proposed import tariffs could lead to higher U.S. consumer prices. Given the current vigour of the U.S. economy, however, such policies may temper the pace and extent of further U.S. rate cuts. Recent economic statistics suggest that manufacturing activity in much of the West is slowing, and the prospect of tit-for-tat tariffs may further dent business confidence.

This uncertain backdrop could be a recipe for a downturn in equity markets at some point over the next year. The sub-advisor, however, does not expect to alter the Fund's portfolio positioning and will continue to invest in companies that should offer attractive returns over time.

## **Related-Party Transactions**

# Manager, Trustee and Portfolio Manager

RBC GAM is an indirect, wholly owned subsidiary of Royal Bank of Canada ("Royal Bank") and is the manager, trustee and portfolio manager of the Fund. RBC GAM is responsible for the Fund's day-to-day operations, holds title to the Fund's property on behalf of its unitholders, provides investment advice and portfolio management services to the Fund and appoints distributors for the Fund. RBC GAM is paid a management fee by the Fund as compensation for its services. The Fund pays a fixed administration fee to RBC GAM,



which, in turn, pays certain operating expenses of the Fund. Both the management fee and fixed administration fee are calculated and accrued daily as a percentage of the net asset value of each series of units of the Fund. RBC GAM, as trustee, earns a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

RBC GAM or its affiliates may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, securities lending, foreign exchange and derivatives transactions. RBC GAM or its affiliates may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies. The Fund also maintains bank accounts and overdraft provisions with Royal Bank for which Royal Bank may earn a fee. Affiliates of RBC GAM that provide services to the Fund in the course of their normal businesses are discussed below.

#### **Distributors**

RBC GAM, Royal Mutual Funds Inc., RBC Direct Investing Inc., RBC Dominion Securities Inc. and Phillips, Hager & North Investment Funds Ltd. are principal distributors of, or may distribute certain series of units of, the Fund. Dealers may receive an ongoing commission based on the total value of their clients' investment in certain series of units of the Fund.

# Registrars

RBC GAM, RBC Investor Services Trust ("RBC IS") or Royal Bank (or a combination thereof) are the registrars of the Fund and keep records of who owns units of the Fund. The registrars earn a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

#### Custodian

RBC IS is the custodian and holds the assets of the Fund. RBC IS earns a fee as the custodian, which is paid by the manager from the fixed administration fee paid by the Fund.

# **Securities Lending Agent**

To the extent the Fund may engage in securities lending transactions, RBC IS may act as the Fund's securities lending agent. Any revenue earned on such securities lending is split between the Fund and the securities lending agent.

## **Brokers and Dealers**

The Fund has established standard brokerage and dealing agreements at market rates with related parties. For the periods ended December 31, 2024 and 2023, the related-party commissions were \$1,000 (2023 - \$1,000) or 5% (2023 - 2%) of the total transaction costs paid for this Fund.

### Other Related-Party Transactions

Pursuant to applicable securities legislation, the Fund relied on the standing instructions from the Independent Review Committee with respect to one or more of the following transactions:

Related-Party Trading Activities

- (a) trades in securities of Royal Bank;
- (b) investments in the securities of issuers for which a related-party dealer acted as an underwriter during the distribution of such securities and the 60-day period following the conclusion of such distribution of the underwritten securities to the public;
- (c) purchases of equity, debt securities or mortgages from or sales of equity, debt securities or mortgages to a related-party dealer, where it acted as principal; and

## Inter-Fund Trading

(d) purchases or sales of securities of an issuer from or to another investment fund or managed account managed by RBC GAM.

The applicable standing instructions require that Related-Party Trading Activities and Inter-Fund Trading be conducted in accordance with RBC GAM policy and that RBC GAM advise the Independent Review Committee of a material breach of any standing instruction. RBC GAM policy requires that an investment decision in respect of Related-Party Trading Activities (i) is made free from any influence of Royal Bank or its associates or affiliates and without taking into account any consideration relevant to Royal Bank or its affiliates or associates, (ii) represents the business judgment of the portfolio manager, uninfluenced by considerations other than the best interests of the Fund, (iii) is in compliance with RBC GAM policies and procedures, and (iv) achieves a fair and reasonable result for the Fund. RBC GAM policy requires that an investment decision in respect of Inter-Fund Trading is in the best interests of each Fund.

There is not necessarily a relationship between a high turnover rate and the performance of the Fund. The portfolio turnover rate is not applicable to money market funds.


Series 0 – no management fees are paid by the Fund with respect to Series 0 units. Series 0 unitholders pay a negotiated fee directly to RBC GAM for investment-counselling services.

## **PAST PERFORMANCE**
