MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objective and Strategies

The Fund seeks to provide current income and liquidity consistent with short-term money-market rates while preserving the value of the investment.

The Fund is invested primarily in high-quality short-term governmentand corporate-debt securities with a maximum term of 365 days. The Fund's corporate-debt holdings are deemed by major debt-rating agencies to be suitable for conservative investors. The Fund also includes short-term debt issued by Canadian chartered banks and promissory notes issued or guaranteed by Canadian governments or their agencies.

Results of Operations

The Fund's net asset value was \$2.7 billion as of June 30, 2022.

As of June 30, 2022, the current yields were 1.43% for Series A units, 1.42% for Series D units, 1.54% for Series F units and 1.76% for Series O units.

Over the past six months, the Fund's Series A units returned 0.29%. The Fund's return is after the deduction of fees and expenses. See the Financial Highlights section for the management expense ratios and the Past Performance section for the returns of any other series, which may vary because of differences in management fees and expenses.

COVID-19-related lockdowns were largely lifted early in the first half of 2022, leading to faster growth in the Canadian economy. However, the expansion was at risk of coming to a halt near the end of the second quarter after the fastest global inflation in several decades forced the Bank of Canada (the "BOC") and its peers to hurriedly boost benchmark interest rates. Inflation was exacerbated by Russia's February invasion of Ukraine, which pushed commodity prices to new highs, and extended lockdowns in China due to the country's "zero-COVID" policy, which strained supply chains. The BOC raised its benchmark rate three times during the period – twice in unusually large 0.50-percentage-point increments. As a result, the benchmark rate had risen to 1.50% at the end of the period from 0.25% in January. Short-term market interest rates followed benchmark rates, rising to the highest levels since before the pandemic.

The portfolio manager focused on keeping the average maturity of the Fund somewhat short to avoid the negative impact of price declines caused by rising interest rates. As a result, the Fund was able to reinvest the proceeds of maturing securities at higher interest rates. A significant portion of the Fund's assets were held in asset-backed commercial paper, which offered higher yields than

bankers' acceptances and a wider range of maturities. The supply of commercial paper, another form of short-term unsecured debt, remained relatively thin during the period given that many corporate issuers have turned to other forms of financing. Regulatory liquidity was satisfied through the holding of a core position in provincial and federal paper.

Recent Developments

The BOC's job for the remainder of 2022 will be to balance the threat posed by inflation, which suggests that further interest-rate increases are in store, with the risk that any further increases will restrict growth and even lead to a recession. The portfolio manager plans to continue managing the portfolio such that returns are not compromised by additional rate increases.

Effective June 29, 2022, management fees were reduced as follows: from 0.75% to 0.30% for Series A units; from 0.60% to 0.30% for Series D units; from 0.50% to 0.20% for Series F units; and administration fees were reduced as follows: from 0.05% to 0.02% for Series A, Series D and Series F units.

Effective April 11, 2022, all Advisor Series units with a deferred sales charge option were re-designated as Series A units. Any redemption fees associated with such re-designations were waived by RBC GAM.

Effective April 8, 2022, the RBC Short Term Income Class was merged into the Fund and shareholders of the RBC Short Term Income Class received units of the Fund on a tax-deferred basis.

Related-Party Transactions

Manager, Trustee and Portfolio Manager

RBC GAM is an indirect, wholly owned subsidiary of Royal Bank of Canada ("Royal Bank") and is the manager, trustee and portfolio manager of the Fund. RBC GAM is responsible for the Fund's day-to-day operations, holds title to the Fund's property on behalf of its unitholders, provides investment advice and portfolio management services to the Fund and appoints distributors for the Fund.

RBC GAM is paid a management fee by the Fund as compensation for its services. The Fund pays a fixed administration fee to RBC GAM, which, in turn, pays certain operating expenses of the Fund.

Both the management fee and fixed administration fee are calculated and accrued daily as a percentage of the net asset value of each series of units of the Fund. RBC GAM, as trustee, earns a fee, which is paid by the manager from the fixed administration fee paid by the Fund.



RBC GAM or its affiliates may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, securities lending, foreign exchange and derivatives transactions. RBC GAM or its affiliates may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies. The Fund also maintains bank accounts and overdraft provisions with Royal Bank for which Royal Bank may earn a fee. Affiliates of RBC GAM that provide services to the Fund in the course of their normal businesses are discussed below.

Distributors

RBC GAM, Royal Mutual Funds Inc., RBC Direct Investing Inc., RBC Dominion Securities Inc. and Phillips, Hager & North Investment Funds Ltd. are principal distributors of, or may distribute certain series of units of, the Fund. Dealers may receive an ongoing commission based on the total value of their clients' investment in certain series of units of the Fund.

Registrars

RBC GAM, RBC Investor Services Trust ("RBC IS") or Royal Bank (or a combination thereof) are the registrars of the Fund and keep records of who owns units of the Fund. The registrars earn a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

Custodian

RBC IS is the custodian and holds the assets of the Fund. RBC IS earns a fee as the custodian, which is paid by the manager from the fixed administration fee paid by the Fund.

Securities Lending Agent

To the extent the Fund may engage in securities lending transactions, RBC IS may act as the Fund's securities lending agent. Any revenue earned on such securities lending is split between the Fund and the securities lending agent.

Other Related-Party Transactions

Pursuant to applicable securities legislation, the Fund relied on the standing instructions from the Independent Review Committee with respect to one or more of the following transactions:

Related-Party Trading Activities

- (a) trades in securities of Royal Bank;
- (b) investments in the securities of issuers for which a related-party dealer acted as an underwriter during the distribution of such securities and the 60-day period following the conclusion of such distribution of the underwritten securities to the public;
- (c) purchases of equity and debt securities from or sales of equity or debt securities to a related-party dealer, where it acted as principal; and

Inter-Fund Trading

(d) purchases or sales of securities of an issuer from or to another investment fund or managed account managed by RBC GAM.

The applicable standing instructions require that Related-Party Trading Activities and Inter-Fund Trading be conducted in accordance with RBC GAM policy and that RBC GAM advise the Independent Review Committee of a material breach of any standing instruction. RBC GAM policy requires that an investment decision in respect of Related-Party Trading Activities (i) is made free from any influence of Royal Bank or its associates or affiliates and without taking into account any consideration relevant to Royal Bank or its affiliates or associates, (ii) represents the business judgment of the portfolio manager, uninfluenced by considerations other than the best interests of the Fund, (iii) is in compliance with RBC GAM policies and procedures, and (iv) achieves a fair and reasonable result for the Fund. RBC GAM policy requires that an investment decision in respect of Inter-Fund Trading is in the best interests of each Fund.

¹ The management expense ratio ("MER") is based on the direct expenses charged to the Fund and the Fund's proportionate share of the expenses of underlying funds, if any, for the stated period, excluding commissions and other portfolio transaction costs, and is expressed as an annualized percentage of the daily average net asset value during the period. RBC GAM may, at its discretion and without notice to unitholders, waive or absorb certain operating expenses. MER includes the waiver or absorption by RBC GAM of certain operating expenses, while the MER before absorption shows the MER prior to operating expenses being waived or absorbed by RBC GAM.

Effective June 29, 2022, the management fees for Series A units were reduced to 0.30% from 0.50%; for Series D units were reduced to 0.30% from 0.60%; for Series F units were reduced to 0.20% from 0.50%; and the administration fees for Series A, Series D and Series F units were reduced to 0.02% from 0.05%. If the changes to the management fees and administration fees would have been in effect throughout the financial period ended June 30, 2022, the adjusted MER and adjusted MER before absorption for each series of the Fund would be: Series A -0.20% and 0.35%, Series D -0.17% and 0.35%, and Series F -0.19% and 0.24%, respectively.

Effective March 1, 2020, the administration fees for Series A units were reduced to 0.05% from 0.10%. If the changes to the administration fees would have been in effect throughout the financial year ended December 31, 2020, the adjusted MER and adjusted MER before absorption for each series of the Fund would be: Series A – 0.44% and 0.88%, respectively.

² The Fund's portfolio turnover rate gives an indication of the level of activity employed by the portfolio manager. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund. The portfolio turnover rate is not applicable to money market funds.

³ The trading expense ratio represents total commissions and other portfolio transaction costs of the Fund and the Fund's proportionate share of such costs of underlying funds expressed as an annualized percentage of daily average net asset value during the period. The trading expense ratio is not applicable to fixed-income transactions.


