MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objective and Strategies

The Fund is a strategic asset allocation fund, which focuses on providing long-term capital growth. The Fund invests primarily in units of other mutual funds (called the “underlying funds”), emphasizing equity mutual funds for higher growth potential, with some exposure to fixed-income mutual funds for diversification. The Fund may also invest in underlying funds managed by RBC GAM or an affiliate of RBC GAM, or in exchange traded funds managed by BlackRock Asset Management Canada Limited (“BlackRock Canada”) or an affiliate of BlackRock Canada.

Results of Operations

The Fund’s net asset value was \$5 million as of June 30, 2023.

Over the past six months, the Fund’s Series F units gained 9.7%. The Fund’s return is after the deduction of fees and expenses. See the Financial Highlights section for the management expense ratios and the Past Performance section for the returns of any other series, which may vary because of differences in management fees and expenses.

Financial markets offered decent returns in the first half of 2023 even as macroeconomic conditions deteriorated. Among the factors that supported equities and bonds were optimism that central banks were nearing the end of the current cycle of interest-rate hikes and the superb performance of a handful of technology stocks tipped to benefit from the increased use of artificial intelligence (“AI”). These positives were offset by tighter financial conditions and slower-than-expected growth in China, the world’s second-largest economy. Also bolstering expansions in North America and Europe were declines in oil prices as the economic impact of Russia’s war on Ukraine, which entered its second year, receded somewhat.

The Fund had a neutral position in both stocks and bonds. The stock-market rebound continued into 2023, propelled by diminishing investor concerns regarding inflation and fewer worries about the sustainability of economic growth. The rally was initially broad-based across regions, but returns in the final months of the period were concentrated in a narrow set of U.S. mega-cap technology stocks. Apart from the U.S. large-cap market, which was fuelled by excitement about AI, most major indexes were flat or down. In emerging markets, technology-heavy Taiwan and South Korea gained after underperforming significantly in 2022. Emerging-market equities finished the period up but underperformed developed-market stocks. Returns were bolstered by the Sun Life MFS Global Growth Class and the Fidelity U.S. Focused Stock Fund.

Prices of global government bonds rose in the first half of 2023, reversing some of the losses incurred in 2021 and 2022, as major central banks were able to reduce the pace at which they raised interest rates amid signs of easing inflation and flagging economic growth. The exception was the U.K., where some of the developed world’s fastest inflation forced the Bank of England (the “BOE”) to continue raising rates faster than its peers, even with anemic economic growth. The collapse of several U.S. banks in March boosted demand for government bonds, which are perceived to offer a degree of safety in times of turmoil. In the U.S., the Federal Reserve continued raising short-term benchmark rates, albeit in reduced increments, to a range of 5% to 5.25%. The European Central Bank delivered four rate hikes, putting the policy rate at 4.0%, and communicated its determination to rein in inflation through monetary policy. The BOE increased its benchmark rate to 5% amid persistent demands for higher wages and widespread labour disruptions, and the Bank of Japan remained an outlier with ultra-low rates as inflation remained less of a threat in relative terms.

Returns in the fixed-income segment of the portfolio were boosted by the Invesco Global Bond Fund and the PIMCO Flexible Global Bond Fund.

Recent Developments

The global economy is slowing as higher borrowing costs and tighter financial conditions weigh on activity. At this late stage in the business cycle and with inflation gradually falling, short-term interest rates are likely nearing their peak, bonds are more appealing than they’ve been in a long time, and equity markets could be vulnerable to correction should a recession materialize. The risk premium of stocks to bonds is currently small and, given the portfolio manager’s base case that the economy is headed for a recession over the next year, the Fund is reluctant to hold an overweight position in stocks at this time. As a result, the portfolio manager trimmed the stock allocation by 2 percentage points during the period. The Fund’s allocations to stocks, bonds and cash are now all in line with the portfolio manager’s strategic neutral levels.

Related-Party Transactions

Manager, Trustee and Portfolio Manager

RBC GAM is an indirect, wholly owned subsidiary of Royal Bank of Canada ("Royal Bank") and is the manager, trustee and portfolio manager of the Fund. RBC GAM is responsible for the Fund's day-to-day operations, holds title to the Fund's property on behalf of its unitholders, provides investment advice and portfolio management services to the Fund and appoints distributors for the Fund. RBC GAM is paid a management fee by the Fund as compensation for its services. The Fund pays a fixed administration fee to RBC GAM, which, in turn, pays certain operating expenses of the Fund. Both the management fee and fixed administration fee are calculated and accrued daily as a percentage of the net asset value of each series of units of the Fund. RBC GAM, as trustee, earns a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

RBC GAM or its affiliates may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, securities lending, foreign exchange and derivatives transactions. RBC GAM or its affiliates may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies. The Fund also maintains bank accounts and overdraft provisions with Royal Bank for which Royal Bank may earn a fee. Affiliates of RBC GAM that provide services to the Fund in the course of their normal businesses are discussed below.

Distributors

RBC GAM, Royal Mutual Funds Inc., RBC Direct Investing Inc., RBC Dominion Securities Inc. and Phillips, Hager & North Investment Funds Ltd. are principal distributors of, or may distribute certain series of units of, the Fund. Dealers may receive an ongoing commission based on the total value of their clients' investment in certain series of units of the Fund.

Registrars

RBC GAM, RBC Investor Services Trust ("RBC IS") or Royal Bank (or a combination thereof) are the registrars of the Fund and keep records of who owns units of the Fund. The registrars earn a fee, which is paid by the manager from the fixed administration fee paid by the Fund.

Custodian

RBC IS is the custodian and holds the assets of the Fund. RBC IS earns a fee as the custodian, which is paid by the manager from the fixed administration fee paid by the Fund.

Securities Lending Agent

To the extent the Fund may engage in securities lending transactions, RBC IS may act as the Fund's securities lending agent. Any revenue earned on such securities lending is split between the Fund and the securities lending agent.

Other Related-Party Transactions

Pursuant to applicable securities legislation, the Fund relied on the standing instructions from the Independent Review Committee with respect to one or more of the following transactions:

Related-Party Trading Activities

- (a) trades in securities of Royal Bank;
- (b) investments in the securities of issuers for which a related-party dealer acted as an underwriter during the distribution of such securities and the 60-day period following the conclusion of such distribution of the underwritten securities to the public;
- (c) purchases of equity and debt securities from or sales of equity or debt securities to a related-party dealer, where it acted as principal; and

Inter-Fund Trading

- (d) purchases or sales of securities of an issuer from or to another investment fund or managed account managed by RBC GAM.

The applicable standing instructions require that Related-Party Trading Activities and Inter-Fund Trading be conducted in accordance with RBC GAM policy and that RBC GAM advise the Independent Review Committee of a material breach of any standing instruction. RBC GAM policy requires that an investment decision in respect of Related-Party Trading Activities (i) is made free from any influence of Royal Bank or its associates or affiliates and without taking into account any consideration relevant to Royal Bank or its affiliates or associates, (ii) represents the business judgment of the portfolio manager, uninfluenced by considerations other than the best interests of the Fund, (iii) is in compliance with RBC GAM policies and procedures, and (iv) achieves a fair and reasonable result for the Fund. RBC GAM policy requires that an investment decision in respect of Inter-Fund Trading is in the best interests of each Fund.

¹ The management expense ratio ("MER") is based on the direct expenses charged to the Fund and the Fund's proportionate share of the expenses of underlying funds, if any, for the stated period, excluding commissions and other portfolio transaction costs, and is expressed as an annualized percentage of the daily average net asset value during the period. RBC GAM may, at its discretion and without notice to unitholders, waive or absorb certain operating expenses. MER includes the waiver or absorption by RBC GAM of certain operating expenses, while the MER before absorption shows the MER prior to operating expenses being waived or absorbed by RBC GAM.

² The Fund's portfolio turnover rate gives an indication of the level of activity employed by the portfolio manager. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher the portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund. The portfolio turnover rate is not applicable to money market funds.

³ The trading expense ratio represents total commissions and other portfolio transaction costs of the Fund and the Fund's proportionate share of such costs of underlying funds expressed as an annualized percentage of daily average net asset value during the period. The trading expense ratio is not applicable to fixed-income transactions.
